- 12. **Study concept and general goals of education** (The graduate profile):

Education program which was developed for Scandinavian Studies (SS), considers the interdisciplinary character and stresses particular profiling of the new specialists in knowledge of Scandinavian countries (Denmark, Finland, Iceland, Norway, Sweden) perceived as a culturally and politically similar, and such preparation can facilitate obtaining employment. Studies will encompass cultures, geography, history, law, and economies of Scandinavian countries. Acquired knowledge will be indispensable if one is to get a job in international institutions, or Polish-Scandinavian businesses. This program will also include practical experiences and qualifications, which will enable a graduate to function in Scandinavian business environment as well as within the Polish governmental institutions engaged in cooperation with Scandinavian States and business entities.

Graduates majoring in Scandinavian Studies as future professionals in Scandinavian affairs, will gain interdisciplinary and multifaceted knowledge, which will be the result of education process delivered by lecturers at the Department of North European Countries (DNEC), which offers a wide variety of scientific disciplines and sub disciplines such as: political sciences, international relations, law, economics and history. It should be stressed that the lecturers at DNEC have been involved in researches concerning Scandinavia for many years. Their academic achievements, didactic experience and international as well as domestic contacts guarantee high level of knowledge upon gaining a BA degree from SS.

Due to strong ties of the Jan Kochanowski University in Kielce (UJK) with local government and businesses located within the Świętokrzyski Region, the students will also be able to gain practical experience, useful in their professional life. People actually working with Scandinavian entities will share their expertise with the future students at SS. It is the conviction of the applying body that professionals with the knowledge of Scandinavian Countries, their economy, and business culture will be sought after by businesses in the near future. According to Scandinavian-Polish Chamber of Commerce, Scandinavian Countries are the second trade partner for Polish businesses. What is more, Scandinavian businesses are the fifth largest investor in Polish economy. Employment by Scandinavian entities such as: IKEA, JYSK, JULA, STATOIL, SKANSKA, VOLVO, NOKIA, SAAB, CARLSBERG, ELECTROLUX is counted in thousands of Polish people. Świętokrzyski Region became a popular place for Scandinavian businesses to locate these are: JULA, JYSK, H&M, VOLVO. Professionals able to speak English and one Scandinavian languages will be needed. Besides Scandinavian trading and investment activities there is cooperation being realized by Norwegian Financial Mechanism and Norwegian Funds. According to the guidelines of these funds the Polish governmental institutions are to realize various projects in Poland. Therefore, professionals trained in processing applications for funds and managing selection of projects and then monitoring their progress will be necessary. Graduates of the Scandinavian Studies program at the Jan Kochanowski University in Kielce will be well prepared for such jobs.

Norway is presently a home to 100,000 Poles. This is the largest national group in Norway. Iceland is a home to 10,000 Poles. It is in Poland's vital interest to have properly educated people to help Poles living in Denmark, Finland, Iceland, Norway and Sweden. These people involving help to Poles there will be most likely employed by the Polish Diplomatic Corp.

The intent of establishing Scandinavian Studies is to facilitate a constant and fruitful cooperation with potential employers of graduates. The goal is to continual enriching program by introducing new subjects (resulting from experiences and signals of business community) to prepare our graduates to fit the needs of potential employers.

THE GRADUATE PROFILE

A graduate of Scandinavian Studies (SS) BA degree will have a wide range of knowledge about Scandinavian Countries (Denmark, Finland, Iceland, Norway and Sweden), particularly about social economic, legal and political aspects of functioning in Scandinavian countries. This knowledge will allow a graduate to understand complex reality of complex reality of Scandinavian countries and the place of Scandinavia in world-wide economy. Educational program was conceived so a graduate can use earned skills at work and be able to analyse internal issues of Scandinavian countries in the international perspective. A graduate of SS will acquire interdisciplinary knowledge in social science, specifically pertaining to Scandinavian history, conceptions, ideas and cooperation, integration of Scandinavian states. Knowledge of genesis, principles of functioning within the Scandinavian economic and social area will be acquired. Above this Scandinavian systems of security will be learned as well as economic and legal fundamentals of functioning of Scandinavian societies. Knowledge of one of Scandinavian languages at A1 level at least and also working knowledge of English will be a significant factor in getting a job, especially on international relations posts.

Selecting particular majors and realizing programs contained in them, means that a graduate will be prepared for such posts: analyst and specialist in public and governmental institutions, international organizations meaning in general diplomatic service, institutions domestic (governmental and non) cooperating with foreign entities.

Interdisciplinary education affords for work in institutions other than having international relations. Posts within administrations governmental and nongovernmental, domestic organizations and international cooperating with Scandinavian states, and also in European Union Structures and businesses. Institutions propagating cultural affairs and media cooperating with Scandinavian countries. A stress is placed on business education, especially needed or work with Scandinavian businesses within Poland. Systematized knowledge in particular majors will be used in professional life in the following fields: communication, negotiations, business management, law and diplomatic relations. A graduate will receive skills indispensable in performing tasks of

information management, and transforming knowledge of economy, internal politics and international relations. Selection of courses is to allow one to see the problem at hand in an integrated and complex manner. Assumed effects of education in particular majors are so formulated that a graduate will be able to be flexible and efficiently react to the needs of labour market. Continuous education will become a habit, therefore a graduate will be ready to continue education toward second degree level.

A graduate with a BA degree in Scandinavian Studies is characterized by:

- o basic knowledge in Political Science and international relations,
- o knowledge of legal-international, constitutional and political fundamentals of external activities of Scandinavian Countries (Denmark, Finland, Iceland, Norway and Sweden),
- o understanding of organization of the state and mechanisms and goals of external policies,
- o knowledge of selected economic, legal, social-political conditions of internal policies in Scandinavian countries, and also knowledge of various aspects of functioning of political, administrative, and security institutions,
- o theoretical knowledge and practical skills allowing for team cooperation in public and private entities,
- o basic ability to analyse international relations based on scientific knowledge,
- o skill to use source materials,
- o skill to formulate prognosis in economic, foreign policy, and international relations while using appropriate tools and methods,
- o ability to formulate own opinions about international events,
- o responsibility and independence while working on assigned tasks,
- o basic knowledge of negotiating,
- o basic knowledge to run a businesses,
- o skill to communicate in an international environment,
- o preparation to continue education toward a higher degree.

The following areas of knowledge are acquired upon completing Scandinavian Studies, being a result of realization of educational effects in particular majors:

- o Administrative and organizational (tied with understanding of functioning of selected institutions.
- o Supervising (connected with ability to direct administrative processes in numerous types of institutions.
- O Didactic and promotional (connected with passing knowledge about Scandinavian countries and people and shaping image of Scandinavians among other people and promoting models of Scandinavian solutions.
- o Social ((concerning team work especially organizing activities in multicultural populations).
- o Psychological (concerning understanding human limitations and attitudes).
- o Communicative (concerning the ability of communicating with other people in certain social and professional situations).
- o Technical (connected with the ability to use computer).

It should be stressed that SS at UJK offers a unique concept of education nationwide. This major provides solid and multifaceted knowledge in legal, political, economic, social cultural aspects of functioning and evolution of Scandinavian states and societies. At the same time SS equips a graduate in concrete, useful skills and knowledge of clearly defined issues.

Set of minors (Module): BUSINESS AND IMAGE

A graduate of this set of minors (Module) within SS with BA receives education in economics, marketing, communication and image building. The knowledge is theoretical in communication and image building, marketing and management, as is in promoting and advertising, but a special attention is put on applying marketing means in business. Graduates will be able to apply in practice, methods to research and define customers' needs and build appropriate marketing strategies. Skills such as: " to preparing and conducting trade mark's and product's promotional campaign, creating image of a company, institution or organization. Public relations and publicity and monitoring of competition's activities will also be skills a graduate shall possess. A graduate of this specialty will understand the significance of mass media, will know how to gather, interpret, and pass (orally and in writing) information, solve complex professional problems and work in team. Therefore, a graduate will have skills enabling him to perform jobs in communication, advertising, promotions and institutions

conducting media studies. SS graduate will be able successfully function in many businesses, and specifically of this specialty, will possess a solid knowledge in economics, social science, legal and political areas, focused on understanding mechanisms of functioning Scandinavian economies and international economies. Will know how world interrelations in economics shaping conditions of international cooperation. A graduate knows global interrelations and functioning of markets, international laws and principles of such contacts. Graduates are ready to take jobs with Scandinavian businesses, international economic organizations, commerce, public administration of various levels, Polish diplomatic posts in Scandinavia. SS graduates will be characterized by knowledge and practical skills, this will allow them to work in local offices of international concerns in Poland (Scandinavian included), consulting agencies, local governments taking care of foreign entities and also handling cooperation with European Union.

Set of minors (Module): DIPLOMACY AND STRATEGY

BA graduate in SS in this module will receive an exceptional knowledge and skills fusing education in diplomacy, foreign policy, security and defence of Scandinavian states. After graduation in Diplomacy and Strategy one gains knowledge allowing for getting jobs in state structures formulating and realization of foreign policies. Courses in the program will familiarize a graduate with practical aspects of Scandinavian diplomatic services. The content of specialty courses fuses theory with practical aspects of work in public service and foreign service. It is worth noticing that education earned in this major will let a graduate to cooperate with mass media and between public agencies and people. Graduates will also understand and make professional analysis of events occurring in international politics of Scandinavian countries and their decisions or actions in foreign affairs. Educational program devotes much attention to internal and external security in Scandinavian countries. A graduate will be prepared to analyse and monitor processes in security systems of Scandinavian states. Acquired skills will allow graduates to prognosticate directions of security evolution in Scandinavian states. Education received and practical experience acquired while studying this module make graduates ideal candidates for posts in security services such as: Governmental Centre for Security, Bureau of National Security, Defence Department of Poland. Proper preparation enables graduates can work in various nongovernmental agencies, institutes analysing international relations, think tanks in Poland and abroad, which examine contemporary international security problems.

It is noteworthy, that SS are in accord with the Polish Qualification Frame (PQF). Educational effects to be attained are structured and contain knowledge that a student will be familiar with basics of economics,, law, communication, and profound knowledge in Scandinavian countries and affairs. Similar manner of instilling education applies to majors, students will be prepared to solving issues of functioning Scandinavian states, businesses. Graduates will receive

universal skills (Encompasses a wide spectrum of activities in governmental, nongovernmental institutions and businesses). Social competences taught at SS prepare students to work in international affairs with specific stress on Scandinavian people and institutions.

Foreign students must attend Polish language classes obtaining of 4 ECTS credits.

Full-time students are required to take physical education classes of 60 hours, these classes are not assigned to ECTS credits. Students are required to receive training regarding safe and hygienic education conditions, at least 4 hours, in the area taking into account the specificity of education at the university and the type of technical equipment used in the education process. Students have 2 hours of library training.

2. METHODS OF VERIFICATION AND EVALUATION OF THE EFFECTS OF STUDENT LEARNING ACHIEVED BY THE STUDENT IN THE WHOLE CYCLE OF EDUCATION:

The academic teacher determines the detailed learning outcomes and the form of their verification, and then places these information in the course' card. Achieving all the learning outcomes - determined for particular classes - means implementing the assumed concept of education in the field of study and achieving directional effects (achieving the graduate's profile). Verification and evaluation of learning outcomes achieved by the student during the whole education cycle takes place through:

- 1) The diploma process through the diploma the expected learning outcomes are verified. They are assessed by the promoter and reviewer.
- 2) **Student internship** learning outcomes obtained through student internship complement the concept of education. Students complement the knowledge acquired during learning (including skills and competences) with its practical aspects. Verification of effects takes place in accordance with the rules of practice in the direction of Scandinavian Studies.
- 3) **International exchange of students** as a result of obtaining information from students regarding their knowledge, skills and social competences in the context of staying at a partner university.
- 4) **Scientific students organisations achievements** feedback is obtained through external reviews (scientific publications, speeches at conferences, scholarships awarded by the Rector and Minister).
- 5) **Analysing of works activity of graduates** by obtaining feedback from them in the field of knowledge, skills and social competences and their usefulness on the labor market.
- 6) **Survey of employers' opinions** by way of giving opinion by employers of study programs, including assumed learning outcomes and methods of verifying them, especially concerning practical education; transferring information about the usefulness of learning outcomes obtained during the course of studies as part of the professional work performed by the graduate.

In addition, the basis for assessing the implementation of learning outcomes in the course of study are:

Works at various stages of the course / courses - carried out by the student, such as: tests, final papers, presentations, case studies. Tutorials, tests, final work, project - are carried out according to the instructions prepared by the teacher. All additional crediting methods require instructions.

Exams from the course. Questions prepared for the exam should not go beyond the content contained in the course card in the course of the lecture. The student has the right to explain by the teacher assessment received on the exam. The form of the exam: oral, written, test or practical is determined by the lecturer and contained in the course card.

- a) The oral exam should be conducted in the presence of other students or academic employees. At least two weeks before the exam date, the lecturer will provide students in written form exam issues / problems. Their reception is confirmed by a student representative.
- b) The written exam may be organized in a test or descriptive form. The exam is carried out in a didactic room in which it is possible to properly place students, ensuring work comfort and independence. The teacher responsible for the exam has the right to interrupt or cancel the exam in the situation when the student's work is not independent (the student uses unauthorized materials, devices and other student's people's help).

Credit and pass with grade. The teacher defines the evaluation criteria, provides its components and justifies in a descriptive way the grade received by the student on passing.

Forms and methods of conducting classes as well as assessment criteria and its components are specified in the course card.

All forms of verification of the student's achievements obtained as part of the course in a given semester are recorded in the periodic tabs of the student's achievements.
